## 2014 REGENTS' ALUMNI AWARD

---

### PRESENTED BY THE OU ALUMNI ASSOCIATION

The purpose of this award is to honor up to 10 individuals, either alumni or friends of the University of Oklahoma, who have given generously of their time and services to the University. This does not eliminate consideration of donors who provide financial support in addition to giving generously of their time and talent. However, this is not an award based solely on monetary contributions.

Recipients will be honored in the spring. The Chair of the University Board of Regents will present the award. Recipients will receive a plaque and their names will also appear on a permanent plaque in the Oklahoma Memorial Union.

#### **NOMINEE QUALIFICATIONS:**

- Not to rival the Honorary Doctorate Awards or any other award given by the University of Oklahoma.
- Up to 10 per year may be awarded; however, fewer may be given. At least two awards will go to young alumni (42 years or younger), who are helping build support for OU in their area.
- An individual may receive the award only one time.
- Faculty, staff and regents are not eligible for consideration.
- The recipient may qualify through cumulative years of service or through concentrated activities for a brief period of time.
- Special attention should be given to "rising stars" or alumni who have continued their active support of OU after recent graduation.
- Recognition should be not only for "local volunteers" who are highly visible in the alumni program, but for the volunteers across the nation and overseas who support the University.
- Nominees are considered eligible for two (2) additional years if not selected upon first review.

#### **RECOMMENDED BACKGROUND:**

- Demonstration of leadership in working with faculty/staff to help the University achieve its goals.
- Publicizing the University in an area away from the campus to expand awareness of the institution.
- Assistance in student and/or faculty recruitment.
- Coordination of fundraising activities.
- Participation on University committees or advisory councils.

#### **CALL FOR NOMINATIONS:**

- Nominations will come from members of the Advisory Council, University staff representatives who work directly with alumni, and alumni club representatives/officers.
- Nominees shall also be solicited from University Deans and Department Chairs who identify active and outstanding OU alumni.
